And further, if said principal shall conform in all respects to the rules and regulations of the Metropolitan Sewer District of Greater Cincinnati which may from time to time be established by said Director in relation to the discharge of Holding Tank Waste, then this obligation shall be null and of no effect, otherwise of full force and virtue.
